California Pharmacists Association – Who We Are:

The California Pharmacists Association (CPhA) was founded in 1869 and is the largest state association representing pharmacists. CPhA represents pharmacists, technicians, and student pharmacists from all practice settings. These practice settings include community pharmacy (both independent owners and employees working in chain drug stores), hospitals & health-systems, and specialty practices such as compounding, managed care, and long term care. The CPhA mission is to advance the practice of pharmacy for the promotion of health.

CAPSLEAD (California Pharmacy Student Leadership):

The CAPSLEAD program is designed to encourage student pharmacists to seek active involvement in professional pharmacy organizations and to inspire student pharmacists to become pharmacy leaders. Participating faculty and students collaborate in the planning, implementation, and completion of the annual program. Research projects are presented in the subsequent year at the CSHP and CPhA annual meetings, where student pharmacist participants receive recognition and feedback.

The Don & June Salvatori California Pharmacy Museum:

The Don and June Salvatori Pharmacy Museum contains thousands of pharmacy artifacts from more than two centuries of pharmacy practice. Inspired by California's unique and rich history, the museum celebrates the role of the pharmacist in the promotion of health and wellbeing of Californians since the state's inception in 1850.
